Accordingly, as per this office vide letter No.4088 dated 24.01.2022, the Bid Evaluation Committee has opened the Financial Bids of the 02 Nos. of Technically responsive bidders on 25.01.2022. The details of Financial proposals are as below:

As per Section-II vide clause 33.1 of RFP, within 10 (ten) days of the receipt of Letter of Acceptance, the successful Bidder shall deliver to the Employer a Performance Security of **Three percent (03%)** of the Contract Price, valid for the period of 28 days after the expiry of defect liability period of whole work in accordance with Clause 28.3 of ITB and sign the contract. The validity shall Account for additional 03 months time to account for BG verification, signing the contract and start date.

In this regard, the successful L1 bidder **M/s. Ganapathi Stone Crushers Pvt. Ltd.** has to submit Performance Security at **03%** of the Contract price i.e. **Rs.23,50,699/-** within 10 days after receipt of the LOA.

As per NHAI Policy Matters-Technical (209-2016) No.NHAI/CM-1/Misc./2016 dt.02.08.2016 and in which vide sl. No. D (i) states that the Regional Officer has been delegated for power of approval for the bids for Maintenance works, where the lowest bid price is upto **05% above**.

Since, the percentage quoted by the L1 bidder **M/s. Ganapathi Stone Crushers Pvt. Ltd.** is **(+) 0.00%** and which works out to **Rs.7,83,56,602/-** excluding GST at 12% as against the Contract amount of **Rs.7,83,56,602/-** excluding GST at 12% and as such it comes within the delegation powers of RO.

In view of the above, as per the Policy circular the Bid Evaluation Committee recommends to issue LOA to L1 bidder **M/s. Ganapathi Stone Crushers Pvt. Ltd.** for the quoted amount of **Rs.7,83,56,602/-** excluding GST at 12%.
