

Minutes of Meeting of Tender Evaluation Committee (Detailed Technical Evaluation) for the work of "Appointment of Safety Consultants (4 Projects) held on 20.01.2022;

- (1) Tolling, Operation, Maintenance and Transfer of four laning of Madurai - Kanyakumari section from Km.0/000 to Km.52/300 of NH-7 (New NH 44) (Toll Operate and Transfer Model) in the State of Tamil Nadu.
- (2) Tolling, Operation, Maintenance and Transfer of four laning of Madurai - Kanyakumari section from Km.52/300 to Km.116/500 of NH-7 (New NH 44) (Toll Operate and Transfer Model) in the State of Tamil Nadu.
- (3) Tolling, Operation, Maintenance and Transfer of four laning of Madurai - Kanyakumari section from Km.116/500 to Km.180/000 of NH-7 (New NH 44) (Toll Operate and Transfer Model) in the State of Tamil Nadu.
- (4) Tolling, Operation, Maintenance and Transfer of four laning of Madurai - Kanyakumari section from Km.180/000 to Km.243/170 of NH-7 (New NH 44) (Toll Operate and Transfer Model) in the State of Tamil Nadu.
