Cancellation Notice

Sub: Filling of Pot-holes and Patch repairs on Ambala-Shazadpur-Naraingarh-KalaAmb section of NH-72 between Chainage km. 1+000 to km. 9+250 and km. 26+600 to km. 46+000 in the State of Haryana (5th call)– reg (Tender ID: 2021_NHAI_99893_1)

1. The committee had assembled for online opening of technical bids at 1130 hrs on 05.01.2021. Accordingly technical bids was opened online as per provision of bid document. On opening of bids, the committee found that only one bidder has participated in the bidding, the detail of which as under:-

1.	M/s SS Associates #8988/5 Bazar Radha Krishan, Ambala City -Haryana

2. Thereafter, with the approval of PD, PIU Chandigarh committee decided to evaluate the technical bid of the bidder.
3. The committee examined the technical bids as per criteria stipulated in bid document and observed that bid of the bidder have defect as per clause 12.2 (d) of section II of RFP which states that "Original Written Power of Attorney of the signatory (whose digital signature certificate is used during e-tender submission) of the bidder to commit the bid (format enclosed in section IV). The authorized signatory holding Power of Attorney or the person executing/delegating such POA shall only be the Digital Signatory otherwise bid shall be considered non-responsive". As Power of Attorney in bid documents is in name of Sh. Sanjeev Bansal and DSC used is of Sh. Sandeep Bansal.
4. In view of above, the committee decided that with the approval of PD PIU Chandigarh, as per clause 12.2 (d) of RFP bid of SS Associates may be considered non-responsive and Authority hereby cancel the bidding process for the subject work. This is for information of all concerned.
