The Technical bids of following bidders have been received till bid due date and time -

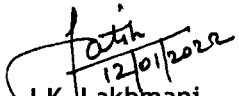

As seen from bid evaluation report, Ref. Annex-1, 5 nos. of bidders viz. M/s Moksh Innovations Incorporation, M/s Descon Infrastructures Pvt. Ltd., M/s Biswajyoti Bhattacharyya, M/s SK Constructions & M/s Dhingra Brothers (India) qualify all the technical evaluation criteria's.

M/s VMS Nirman Pvt. Ltd. has failed to qualify the technical evaluation criteria referred in clause 4.4 A (b) regarding satisfactorily completing similar work. M/s EQRA International has failed to qualify the technical evaluation criteria referred in clause 4.6 regarding available bid capacity.

Accordingly, the committee is of the view that, after obtaining approval of Competent Authority/ RO-UP (East) on technical evaluation report of the committee, financial bids of above mentioned qualified bidders (05 nos.) shall be opened after intimating the bidders through short notice by PD, PIU, Varanasi.

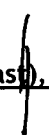

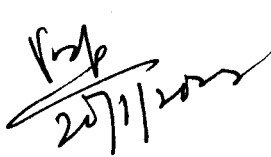
