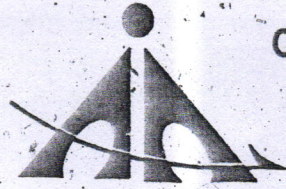

Sir,

1. उपर्युक्त निर्दिष्ट कार्य हेतु आपकी निविदा अध्यक्ष भारतीय विमानपत्तन प्राधिकरण की ओर से स्वीकार की जाती है, और आपके द्वारा उद्धृत प्रतिशत दर जो कि अनुसूची दरों (डीएसआर -2018 एवं एडिशनल मिसलैनेयस आइटम) से 52.28 प्रतिशत कम है, जिसमें निविदा दस्तावेज की अनुसूची-अ शामिल है। काम की लागत रुपये 14,31,600/- (रुपये चौदह लाख इक्तीस हजार छ' सौ मात्र) जीएसटी को छोड़कर होगी।

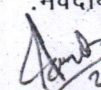
