Subject: - E-Tender for award of License for Duty Paid Liquor Shop in Arrival in New Terminal Building at Dehradun Airport (E-Tender No. 2022_AAI_102034_1).

Sir,

Please refer to your Bid for E-Tender No. 2022_AAI_102034_1. In this regard, it is hereby intimated that your bid for License for Duty Paid Liquor Shop in Arrival in New Terminal Building at Dehradun Airport has been accepted by the Competent Authority with following terms and conditions: -

1. **Period of Concession:** The period of concession shall be Five (05) Years.
2. **Monthly License fee:**
 - a. Monthly License fee of **Rs. 1,399/-** (Rupees One Thousand Three Hundred and Ninety-nine only) Per Hundred Domestic arriving passengers * Number of Domestic arriving passenger per month/ 100 **or Rs. 2,48,000/- (MMG), whichever is higher. (Plus)**
 - b. Utility/ Facilitation Charges at 10% of normal space rent (or as may be notified by AAI from time to time, presently normal notified A/c space rent is Rs. 1000/- Per Sqmtrs. per month. The space rent is subject to annual escalation on 1st April of every year or as decided by AAI from time to time; + **(plus)**)
 - c. All Government Taxes including GST at applicable rates notified by Government of India/State Government/UT from time to time;
3. **Electricity/Water Charges:** In addition to above, charges towards consumption of electricity and water, as may be notified/directed by the Authority and at the rate(s) notified from time to time are payable.
4. **Advance License Fee:** One-month advance license fee of **Rs. 9,40,866/-** (License Fee @Rs 7,91,344/- + Utility charges @ Rs. 6,000/- + GST @ Rs.1,43,522/-) **(Rupees Nine Lacs Fourty Thousand Eight Hundred and Sixty-Six only)** is payable in the form of NEFT/ RTGS in favour of Airports Authority of India at Dehradun **within 15 days** from the date of issue of this award letter.
5. **Interest on delayed payment:** The concessionaire has to make the payment of the License Fees etc. by 25th of same month, failing which interest on delayed payment shall be charged at the rate of 9% per annum from the due date for the delay period of upto 30 days and if delay is for more than 30 days, then interest rate @ 18% per annum shall be charged from the due date, for entire delay period.

6. **Business Incubation Period** shall mean a period of 15 days from the date of issuance of this award letter. The selected bidder will be under obligation to complete all the formalities conditions of award as specified in this award letter.
7. **Handing Over of Sites:** Site will be handed over upon fulfilment of conditions of award within the stipulated time of business incubation period. If the licensee fails to complete the conditions of award which are pre-requisite for handing over of site, then the gestation period will be deemed to have commenced on 16th day of issuance of this LOIA i.e. immediately after expiry of business incubation period. However, actual handing over of sites shall only be done after completion of all conditions of award.
8. **Gestation Period:** Gestation period of 90 Days or actual commencement of Commercial operation, whichever is earlier.
9. **Security Deposit:**
 - (i) Payment of Security Deposit equal 06 (six) months of quoted License Fee, i.e., **Rs. 47,48,066/- (Rupees Fourty Seven Lacs Fourty Eight Thousand Sixty-Six only)** in the form of NEFT/RTGS or BG from a Nationalized / Scheduled bank, **valid upto 06 (six) months** after the expiry of License period, in favour of Airports Authority of India at Dehradun Airport **within 15 days** from the date of issue of award letter.
 - (ii) Payment of Security Deposit equivalent to 5% of annual license/concession fee, i.e. **Rs. 4,74,807/- (Rupees Four Lacs Seventy-Four Thousand Eight Hundred and Seven only)** is to be submitted for electricity/ water/telephone etc. in the form of NEFT/RTGS or BG from a Nationalized/Scheduled bank, **valid upto 06 (six) months** after the expiry of Licence period, in favour of Airports Authority of India at Dehradun Airport **within 15 days** from the date of the issue of award letter.

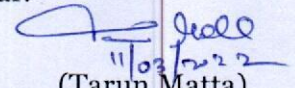

 - (v) Name of Contact person along with contact number and Email Id, where the bills and other official correspondence are to be forwarded, may please be provided to this office.
10. **License Agreement** is to be executed on a Non-Judicial Stamp Paper (denomination of Rs.100/-) within 15 days from the date of issuance of this award letter.
11. The necessary Airport Entry Permits to the authorized representative(s) and employees of the concessionaire shall be issued on behalf of Airport Director as per rules/regulations of BCAS. It shall be responsibility of the Licensee to obtain character verification and other relevant documents for this purpose.

12. All the formalities related to Bureau of Civil Aviation Security (BCAS) i.e., obtaining Provisional Security Clearance/ Security Clearance through e-sahaj portal and submission of Security Programme, are to be strictly adhered to. Necessary assistance/ guidelines, if required may be obtained from the Airport Operator/BCAS in this regard. The above are mandatory requirements for continuing business in the Airport Premises.
13. The Licensee shall be permitted to sale Foreign made Foreign Liquor (FMFL), Premium Indian made Foreign Liquor (IMFL), all types of wines or as stipulated in the respective State Govt. policy in which the Airport is located. All policy of State Government, where the Airport is located, shall be followed.
14. This Award letter along with other clauses of NIT shall form part and parcel of the License Agreement.
15. All other terms and conditions shall be applicable as per other Clauses of NIT.

You are requested to convey your acceptance along with copy of this Award letter (duly signed by the authorised signatory) within 7 days of issuance of this award letter and also complete other formalities as per para 4, 9 & 10 above, failing which the EMD shall be forfeited and licensee will be debarred from participating in any tender of AAI for a period of one year.
