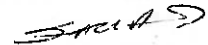
1. Your bid for the subject work mentioned above is hereby accepted on behalf of Chairman, Airports Authority of India, at your quoted fee 0.46% (Zero Point Four Six percentage only) (Excluding GST) of approved estimated cost or awarded cost or actual completion cost of execution contracts, whichever is less (excluding the cost of major bought out items).

For all major bought out items i.e. Escalators, Elevators, Baggage Handling system, Passenger Boarding Bridges, D.G. Sets, Transformers & X-Ray Machines etc. the Consultancy fee payable shall be worked out considering the above quoted percentage fee on 25% of Least of the Estimated Cost/Awarded cost/Actual Completion cost of the particular bought out item.

2. GM (Engg-Civil), O/o ED Engg-NR, AAI, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi-110003 and for matters relating to Post award/Execution (phase-1) and Post-Completion of Execution (Phase-I), shall be Jt. GM (Engg.-Civil), AAI, Udaipur Airport. You are requested to attend the office of Jt. GM (Engg-Civil) O/o ED Engg-NR, AAI, Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi-110003 within 15 days from the date of issue of this letter to sign and complete the contract agreement. The contract agreement shall be executed on a non-judicial stamp paper of value Rs. 100/- (Rupees One Hundred only) and the cost of the stamp paper shall be borne by you.
3. Security deposit shall be recovered as per clause 4.3/page 127 of the tender document, If you want non deduction of Security amount from the running bills, in such case the amount likely to be deducted as security of Rs. 11,26,015.00 /- (Rupees Eleven Lakhs Twenty Six thousand fifteen only) can be deposited by you in the form of Bank Guarantee from Nationalized Bank or any Scheduled Bank but not co-operative or Gramin Bank in accordance with the prescribed form (as per Annexure-IX, Page 221-223), failing which the same shall be deducted as per clause 4.3/page 127 of the tender document.

4. Within 30 days from the date of issue of this letter, you shall submit to AAI, a performance Guarantee as per Clause 7.0 on page 133 of tender document for an amount of Rs. 6,75,609.00 (Rupees Six Lakhs Seventy Five Thousand Six Hundred Nine Only) in the form of a Bank Guarantee from a Nationalized/Scheduled Indian Bank but not from any co-operative or Gramin Bank in the proforma appended as per Annexure- XI, page 227-228 in the tender document.
5. You are requested to comply with the provision of contract labour (Regulation & abolition) Act of 1970 and contract labour (Regulation & Abolition) Central Rules 1971, Child Labour (Prohibition & Regulation) Act 1986, Construction workers (Regulation of Employment and Conditions of Service) Act 1996, Building and other Construction workers Welfare Cess Act 1996, Minimum Wages Act 1948, Employees Provident Fund & Misc. Provisions Act 1952 and ESI Act 1948, amended from time to time as specified in clause 15 (iii) of page 117 and rules thereof central and State Governments.
6. You are also advised to contact Jt GM (Engg.-Civil) O/o ED Engg-NR, AAI, Rajiv Gandhi Bhawan, and Safdarjung Airport, New Delhi-110003 immediately for further details related to the work.
7. Please note that the time allowed for carrying out the work shall be 32 (Thirty Two) months (06 months for Pre-Award / Planning Activities + 24 months for Post-Award/Execution (Phase-I) Work+ 02 month for Post-Completion of Execution and same shall be reckoned from the 15th day from day from the date of issue of this letter.
