The Technical and Financial bid of the subject tender were opened on 27.04.2022 and 20.05.2022 respectively wherein you have emerged as the H1 bidder. In this regard, approval of the Competent Authority is hereby conveyed to grant the License in your favour as per the following terms and conditions: -

1	License	License to Operate Chemist Outlet at Departure Check-in area in the Domestic Terminal. (15.33 Sqmtr).
2	Gestation period	Since M/s. Apollo Pharmacies Ltd is the existing licensee for the facility in the same location, no gestation period is permitted.
3	Period of concession	Five (05) years w.e.f. 14.06.2022 to 13.06.2027.
4	License fee	1. Rs. 4,05,000/- (Rupees Four Lakhs Five Thousand only) per month plus applicable taxes for the first year subject to escalation as per Clause 4 of NIT. 2. Utility/Facilitation Charges at 10% of normal space rent for allotted space as notified by AAI from time to time (For the financial year 2022-23 the space rent charges will be Rs. 2150/- Per Sqm Per Month for Non-AC space and Rs. 3230/- Per Sqm Per Month for A/C space. Further from 01.04.2023 the rates are subject to annual escalation @ 7.5% compounding on 1st April of every year or as may be notified by AAI from time to time).



		3. All applicable Government Taxes including GST (presently at the rate of 18%) or at the rates declared by Government of India or State Government from time to time. 4. Charges for the consumption of the electricity and water consumed for the purpose of use of the said license as becomes due and payable and in accordance with the directions of the Authority and at the rates as fixed by AAI from time to time.
5	Security Deposit (Non-Interest Bearing)	Rs.19,35,000/- (Rupees Nineteen Lakhs Thirty Five Thousand only) towards License Fee, Utility Charges etc. Rs 2,43,000/- (Rupees Two Lakhs Forty-Three Thousand Only) towards security deposit in respect of electricity charges. Total =Rs. 21,78,000.00 (Rupees Twenty-One lakh Seventy Eight Thousand Only). Mode: RTGS/NEFT/Bank Guarantee. If Bank Guarantee is submitted, bank guarantee should be from a nationalised/scheduled bank. Bank guarantee from co-operative banks, even scheduled co-operative banks, shall not be acceptable
6	Advance license fee	Rs.4,83,743/- (Rupees Four Lakhs Eighty-Three Thousand Seven Hundred and Forty-Three Only) inclusive of GST.
7	License agreement	Execution of license agreement (as per NIT) on stamp paper of Rs.100/-. All related costs to be borne by the licensee.

8. All formalities/conditions of award as specified herein are to be completed **within 30 days of issuance of this letter** in the order mentioned herein:

- Payment of outstanding dues at all AAI controlled airports pertaining to the period till the date of issuance of LOIA.
- Acceptance of the offer within seven (07) days from the date of issuance of the LOIA. The acceptance letter must declare the clearance of all outstanding dues as mentioned above.
- Payment of advance license fee for one month within Thirty (30) days from the date of issuance of the LOIA.
- Payment of Security Deposit as specified in para-6 within Thirty (30) days from the date of issuance of LOIA.
- Execution of the Agreement within Thirty (30) days from the date of issuance of LOIA on stamp paper of Rs.100/-

9. Please note that non-acceptance of award or non-completion of the above formalities within the time stipulated herein may result in **forfeiture of Earnest Money Deposit and/or**

debarment for further participation in the tenders at AAI airports or at any other place in control of AAI for a period of one (01) year.
