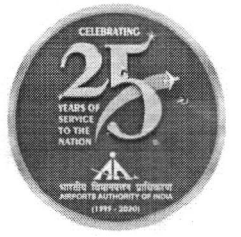
1. The period of license is three years.
2. License fee shall be payable as under:-
 - i. **Payment of License fee of Rs. 1,77,999.00/- (Rupees One Lakh Seventy Seven Thousand Nine hundred ninety nine Only) per month+**
 - ii. **TCS@ 2% of License Fee**
 - iii. **GST@18%.**
3. In addition to above charges towards consumption of electricity and water as may be notified by the Authority and at the rate(s) notified from time to time, is payable.
4. License fee is payable in advance before 25th of every month failing which interest on delayed payment at the rate of 9% per annum shall be charged from the due date for delayed period of up to 30 days and if delay is for more than 30 days, then interest at the rate of 18% per annum shall be charged from the due date, for entire delay period.

5. One month advance License fee of **Rs. 1,77,999.00/- (Rupees One Lakh Seventy Seven Thousand Nine hundred ninety nine Only)**, exclusive of GST is payable in the form of RTGS/NEFT in favour of Airport Authority of India payable at Prayagraj within 15 days from the date of issue of Award letter.
6. (i) Payment of Security Deposit within 15 days from the date of issue of award letter equal to 04 (Four) months of Equivalent License Fee of first year i.e. **Rs. 7,11,996/- (Rupees Seven Lakh Eleven Thousand Nine hundred ninety six Only)** to AAI as an interest free security deposit. The SD is to be furnished in the form of Bank Guarantee only to be issued by Scheduled Bank having a validity of 180 days from the date expiry of Contract. However, BG from Cooperative Bank (even scheduled) or in the form of FDR is not acceptable.

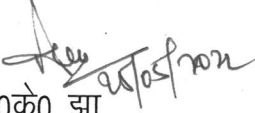
