The agency will permit AAI at the time of making any payment to him for work done under the contract to deduct a sum at the rate of 10% of the gross amount of each running bill till the sum along with the sum already deposited if any as earnest money (if any) , will amount to security deposit of 10% of the tendered value of the work. Earnest money, if any shall be adjusted first in the security deposit and further recovery of security deposit shall commence only when the update amount of security deposit starts exceeding the earnest money(if any).
4. The agency have to comply with the provision of contract labour (Regulation and abolition) Act 1970 and contract labour (Regulation and Abolition) central rules 1971, Minimum wages act payment of wages Act 1936, Minimum wages Act1948, workman compensation Act 1923, Industrial Disputes Act 1947, Employees liability Act 1938, EPF Act 1952, ESI Act 1948, Bonus Act and amended from time to time and shall pay all his own cost all charges and levies and deposits in connection therewith of Central and state Governments.
5. You are also directed to contact the Airport Director or his authorized representative AAI, LGBI airport, Guwahati, before start of the work, who will arrange to hand over the site to you.
6. Please note that the time allowed for carrying out the work shall be 12 months and same shall be reckoned from 01. 06.2022 or from the date of handing over the site whichever is earlier.
7. Payment shall be made on monthly basis for the services rendered based on the Performa Invoice. Any other deductions (if any) will be done as per tender condition and govt. guidelines.
8. You shall pay all the taxes & duties, what so ever including GST, labour cess, octroi if any, work contract tax, Govt cess or any other tax on materials, custom duties, tax on tools and plants and transportation of items upto the Airport/place of work
9. You shall be responsible for setting any claim/compensation against all damages and accidents caused due to negligence on the part of your employees and keep AAI indemnified from any compensation /liability.
