

TECHNICAL SCRUTINY OF ENVELOPE-I AFTER SHORTFALL REQUEST

Name of work:- Management of "May I Help You Counters" at Kandla Airport

Tender ID:- 2022_AAI_ 113307

The Envelope-1 was opened for the above subject tender on 31.05.2022. Total two (02) bidders submitted their bids. PRM Enterprise is debarred by O/o MBB Airport, Agartala vide letter no. AAI/AGT/AGM/BC/2022/229 dated 07.06.2022, so the agency was rejected. Shortfall was requested to rest of bidder M/s. AASIM COMMUNICATIONS PVT LTD on 18.06.2022 upto 22.06.2022 till 17:00 hrs. After opening shortfall following was found:-

- 1. PRM Enterprise, 242-243, 2nd Floor, Infinity Arcade, ONGC-Makarpura Road, Vadodara – 390014**

The agency is debarred by O/o MBB Airport, Agartala vide letter no. AAI/AGT/AGM/BC/2022/229 dated 07.06.2022. So agency was not requested any shortfall. Agency is not eligible for opening of its financial bid and further tenders.

- 2. AASIM COMMUNICATIONS PVT LTD, I G Road, Parraypora Bagat, Srinagar, J & K - 190005**

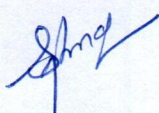

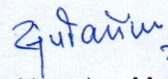
Following shortfall found in documents:

- Work completion certificates and work orders are for MESS and other civil maintenance Works, which are not as similar type of works mentioned in NIT. Work Award Letter issued by Director (FNS HOPE) for "Annual Contract for providing facility management services at FNS HOPE Classes Pvt Ltd Parraypora Bagaat Srinagar dated 27.02.2019 for monthly cost Rs. 4,58,000/- is of similar nature of work but not at "Helpdesk/Information Counters" at airports/ Providing skilled and trained manpower for Airlines Cabin Crew, Airline check-in counters/Managing Executive & Business Lounges at Airports/Providing skilled manpower for 5-star or 3-star Hotel Front Desk/ Managing "Helpdesk/ Information Counters" in MNC Buildings/ Managing "Helpdesk/Information Counters" in Multi-Specialty Hospitals. Agency has to submit work experience as per NIT eligibility criteria.
- Agency has to submit details of Manpower on roll will be all employees on the books of the company as per statement of manpower wages/ manpower roll of last quarter.
- Agency has to submit details of its branch offices in different cities. Self-Attested copy of address proof (like utility bills for example Telephone bill, Electricity bill) of agency offices in each city shall be acceptable.
- Agency has to submit presentation on Deployment methodology showcased in presentation will be added to work contract / agreement and contractor will be bound to adhere to it at all costs.

Response:- Agency has not submitted documents as per NIT criteria. Hence, not accepted for opening of financial bids.

In view of above, both the agencies are rejected and not eligible for opening of its financial bid.
