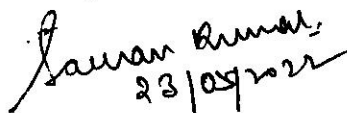

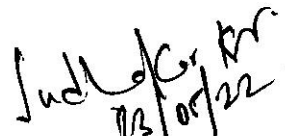
The technical evaluation committee for the above BID has extensively gone through the documents submitted by the bidders and concluded as below:

- M/s Business Centre.Net has submitted the asked shortfall documents and found ELIGIBLE for this BID.

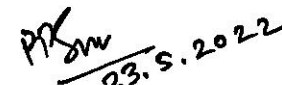
