2. M/s Babul and M/s Traders Associates are MSME enterprise and have experience in similar field but they do not fully meet the experience criteria i.r.o. work order value.
But as per GoI Ministry of MSME rules (Policy Circular No. 1(2)(1)/2016-MA/Dated 10.03.2016 - para 4) relaxation may be given to them in case of experience.
