Please deposit **Rs. 4,80,000.00 (Rupees Four Lakhs Eighty Thousand Only)** towards security deposit within 10 days from the date of issue of this letter failing which, the same will be deducted as per condition of Clause no. 1A at page no. 16 of contract document.
4. You are requested to comply with the provision of Contract labour (Regulation and Abolition) Act 1970 and contract labour (Regulation and Abolition) Central rules 1971 Child Labour (Prohibition & Regulation) Act 1986, Construction Workers (Regulation of Employment and Condition of Service) Act 1996, Building and other construction Workers Welfare Cess Act 1996 as specified in Clause 19 on page no. 49 of GCC of tender and rules of Central and State Government.
5. You are also directed to contact AGM (Engg-Civil) immediately who will arrange to hand over the site to you.
6. Please note that the time allowed for carrying out the work shall be 12(**Twelve**) **months** and same shall be reckoned from the 10th day after the date of issue of this letter.
