3. Please deposit **Rs. 6,00,000.00 (Rupees Six Lakhs Only)**, towards security deposit within 10 days from the date of issue of this letter failing which the same will be deducted from your running bills as per clause 1 (A) of GCC of the tender document.

You are requested to comply with the provision of contract labour (Regulation & Abolition) Act of 1970 and contract labour (Regulation & Abolition) Central Rules 1971, Child Labour (Prohibition & Regulation) Act 1986, Construction Workers (Regulation of Employment and Condition of Service) Act 1996, Building and other construction workers Welfare CESS Act 1996 as specified in GCC of Tender and rule of Central and State Government.
5. You are also directed to contact Assistant General Manager (E-C), AAI, Imphal Int. Airport, Imphal, immediately who will arrange to hand over the site to you.
6. Please note that the time allowed for carrying out the work is 12 (Twelve) months and same shall be reckoned from the 10th day of issue of this letter.
