

According to the agency's confirmation, the agency submitted a false declaration in the tender in Annexure G by concealing these facts, which is a matter for the tender inviting authority to examine.

In light of the foregoing, the subject proposal, which is not in accordance with the Commercial Manual or its current amendments, was deemed unsuitable for consideration.

As a result, it is suggested that Agra Airport cancel the tender and prepare the NIT in accordance with the Commercial Manual / amendments / Commercial Circulars in effect for re-inviting the tender.

The above examination is submitted for consideration, if agree, the same can be placed before the RED, Sir for his kind consideration / consent please.

This office received proposal for approval of Competent Authority being a single tender for the License to operate Leather Shoes & Accessories Shop in SHA at Agra Airport.

While processing/ scrutiny proposal at RHQ-NR Commercial Department, it is observed that while preparation of tender document the amendments in eligibility criteria has not been considered inadvertently. The Eligibility/Technical criteria as per the Clause 10 (a) of NIT is reproduced as below:

10 (a) " ***The participating agency should have minimum two (02) years of experience during the last five (05) years in operating any of such/similar retail outlets shops at airport, bus terminals, ferry terminals, malls, metro rails and railway station etc....***"

However, the eligibility criteria has been amended vide Commercial Instruction No. 04/2019 dated 06th August 2019, which stipulates that " **the period of**

reckoning of technical experience as stipulated in Annexure IV of the Commercial Manual shall be uniformly kept as two (2) years in the last seven (07) years."

Thus the eligibility criteria is not in accordance with latest circular, therefore, it is recommended that the airport may cancel the tender and initiate the action afresh as per the latest laid down provisions.
