Dear Sir,

The undersigned is pleased to convey the approval of Competent Authority for award of license for F&B facility Near Security Check Point in SHA of Trichy International Airport, to **M/s Navilan Enterprises, Coimbatore** with the quoted Monthly License Fee of **Rs. 3,22,843/-** (Rupees Three Lakhs Twenty Two Thousand Eight Hundred and Forty Three Only) per month, plus applicable GST and other charges as applicable from time to time for a period of two years subject to NIT and following terms & conditions.

1.	License	License for F&B facility at Near Security Check Point in SHA of Trichy International Airport
2.	Period	02 years
3.	Area / Location	7.5 Sq Mtr (approx.) in SHA
4.	License fee	Rs. 3,22,843/- pm + GST and other applicable charges. License fee should be paid on or before 25 th of every month in advance. The tax (GST) is applicable @ 18% subject to revision as per Govt. Directive.
5.	Electricity & Water Charges	As per EB tariff on actual consumption of electricity and water charges at the rates fixed by AAI. The rates are subject to revision from time to time.
6.	Utility / Facilitation Charges	In addition to the license fee, 10% of the actual space rent per month plus GST should be paid towards the utilization / facilitation charges.
7.	Advance License fee	License fee - Rs. 3,22,843/ Utility charges - Rs. 1005/- GST @ 18% - Rs. 58,293/- Total Rs. 3,82,141/- (Rupees Three Lakhs Eighty Two Thousand One Hundred and Forty One Only) shall be paid online to the bank account of AAI, Trichy.
8.	Security Deposit for License Fee	Equivalent to Four months first year license fee amounting to Rs. 12,91,372/- (Rupees Twelve Lakhs Ninety One Thousand Three Hundred and Seventy Two Only) shall be paid online to the bank account of AAI, Trichy / Bank guarantee from any Nationalized Bank except Co-operative Banks.
9.	Security Deposit for Electricity charges	An amount of Rs. 1,93,706/- towards Electricity Deposit shall be paid online to the bank account of AAI, Trichy.

10.	Agreement	An agreement in duplicate in the prescribed format as per NIT is to be executed on non-judicial stamp paper of value of Rs.100/-. Cost of Stamp Paper shall be borne by you. This award letter shall also form part of the Agreement.

Other terms and conditions:

01. After taking over the License, if the License fee and other applicable charges, as per bill, is not paid within the stipulated date, penal interest @ 9% per annum shall be charged from the due date for delayed period upto 30 days and if delay is for more than 30 days, then interest @ 18% per annum shall be charged from the due date for entire delay period be payable on all delayed payment, without prejudice to the Authority's other rights and remedies. Besides, action as deemed necessary will be taken as per the Agreement conditions under the rules and in addition the administrative cost of re-tendering will be deducted from the Security Deposit.

02. That the license for the above said facility shall be valid for the period of 02 years w.e.f immediately after completion of business incubation period, unless terminated earlier on account of following:

- By giving **60 days'** notice in writing from either side without assigning any reason.
- Terminated by AAI on a short notice on account of un-satisfactory performance.
- Termination on expiry of the specified time period allotted for unresolved internal dispute resolution.

03. Penal action, as appropriate, would be initiated on account of unsatisfactory performance such as: (i) Delayed payment of License fee (ii) Non observance of approved rates of items (iii) Not maintaining the quality in providing service/facility (vi) Rate list (v) Any other breach in the terms and conditions of license agreement including notice period for terminating license etc.

04. In case of failure to accept the terms and conditions of the award of license, you will be debarred from participating in any Commercial License/Tender at AAI, at any Airport, for a period of 01 year.

05. The EMD will be forfeited and the party may be debarred for further participation in AAI's tender(s) for a period of 01 year on account of non-compliance of the following :-

- Acceptance of the offer immediately from the date of award letter.
- Payment of advance L/Fee for one month within **15 days** from the date of award letter.
- Payment of Security Deposit within **15 days** from the date of award letter.
- Execution of Agreement within **15 days** from the date of award letter.

06. The acceptance should be conveyed **within 07 days** by signing and returning the duplicate copy of the award letter.

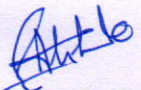
07. The licensee is liable to obtain proper insurance coverage for their properties / goods stored or used in the licensed premises.

08. The licensee shall obey the various Central and State Govt. Labour Laws in force from time to time and ensure their registration etc. as per rules.
09. The licensee shall abide by the rules & regulations and legislation of Central and State Government on Environmental protection.
10. The licensee is liable to implement the AAI commitments and practices on ISO 14001 – 2004 (Environmental Management System).
11. Modification/renovation, if any required in the allotted area should have prior approval of the competent authority of AAI.
12. The licensee shall not unless with the written consent as afore said assign or transfer the present license or any party thereof.
13. The licensee shall abide by the terms and conditions, rules, and regulations of AAI as may be enforced from time to time.
14. In addition all rates, assessments, outgoings and other taxes wherever applicable including the service in respect of the said premises will be payable by the licensee.
15. The licensee shall use the area only for the purpose for which it is allotted and for no other purposes and confine their activities within the space allotted.
16. The allotment is subject to clearance of all outstanding dues, if any.
17. The award letter & e-tender NIT shall form part and parcel of the agreement.
18. The allotment of subject space can be cancelled at short notice if the space required by AAI for expansion/modification of Airport and the licensee shall vacate the space without any protest or claims for compensation.
19. Necessary BCAS clearance to perform the business at the airport has to be obtained before commencement of the facility.
20. Being an existing licensee for the same location, Gestation period is not applicable and the date of commencement of the period shall commence after the expiry of present license (i.e., w.e.f 22.08.2022).
21. You are hereby requested to completed all the above formalities within 15 days and continue the facility as per the terms & conditions of this fresh award letter and NIT.
