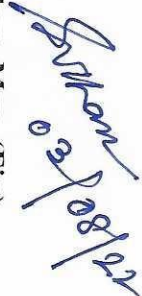

Some of the supporting documents are not submitted by the bidders as per the NIT, which was sought through NIC CPP Portal as shortfall documents. Two parties namely **RBA Hospitality and Hotels Pvt. Ltd. & EMS Veg Café** have been disqualified due to non submission of relevant documents as per the NIT. Hence, all the technical documents submitted by the other five bidders are as per the NIT. Hence, five bidders are technically qualified. Financial bid is to be opened on 03.08.2022 at 17.00hrs.
