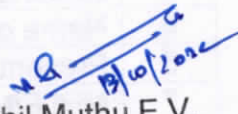

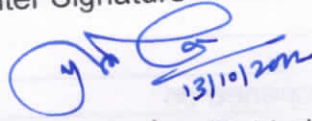

LCAC's Deliberations' -

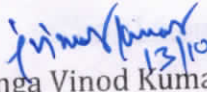
As per E-Office noting: File No. AAI/HBX/22-23/CM/SnackBar the following is put forth -

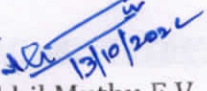
1. Technical bid opened on 16.07.2022 had only one agency participating in the bid despite multiple extensions.

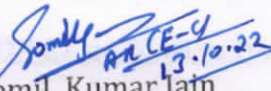

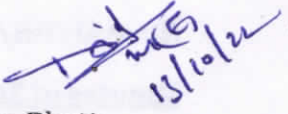
