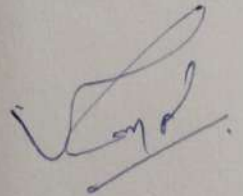
Dear Sir,

1. Reference is made to Tender Id- 2022_AAI_120463_1 of Technical bid & Financial Bid submitted by you on CPP Portal. Your tender for the work mentioned above is hereby accepted on behalf of the Chairman, Airports Authority of India at the item rates (Manpower & Crackers) quoted by you totaling cost for 36 Months to Rs. 58,05,934.80 (Rupees Fifty Eight Lakhs Five Thousand Nine Hundred Thirty Four & Eighty Paise only), (Exclusive of EPF, ESI, Bonus and GST) which is 13.86 % below of the justified amount out to tender of Rs. 67,40,676.00 (Excluding of EPF, ESI, Bonus and GST). Schedule of rates is attached in Annexure I.
2. You are requested to execute an agreement within 15 days from the date of issue of work order to sign and complete the agreement and to do the day to day service activity of your firm etc. The contract agreement shall be executed on a non- judicial stamp paper of adequate value of Rs. 100/- (Rupees One Hundred only) and the cost of the stamp paper will be borne by you as mentioned in NIT Tender Documents.
3. You are hereby request to deposit the Security Deposit (SD) amount of Rs. 5,80,593.00 (Five Lakhs Eighty Thousand Five Hundred Ninety Three Only) within 15 days from the date of issue of work order which will amount to a sum equal to 10% of your quoted amount for three years mentioned in NIT Tender Clause 6.8.1 and the same will be released by AAI as stipulated period mentioned in the Clause.
4. You are requested to comply with the provision of contract labour (regulation and abolition) act of 1970 and contract labour (Regulation and Abolition) central rules 1971 and minimum wages act and rules there of central and state governments whichever is higher.

5. You are hereby requested to setup an office at Agartala to communicate with principal employer (AAI) in effective manner when required within a period of 15 days from the date of issue of work order and the name, address and contact number of the local office shall be provided to this office immediately.
6. Please note that the time allowed for carrying out the work is 36 (Thirty Six) Months, which shall be reckoned from 01-09-2022.
7. You are also requested to provide Crackers per month as per requirement mentioned in the Tender Schedule of Rates as attached in Annexure-I
8. You are also requested to pay the salary of workmen on or before of 07th day of every month as per current wages and also pay the hike of minimum wages if revised from Chief Labour Commissioner (Central) failing which the penalty amount will be deducted from your bill as per Tender NIT clause 6.18.3. Further the revision of wages shall be reimbursed to you as per Tender Clause 6.11.3
9. You are also requested to provide uniform to the workmen of approved colour as mentioned in the Tender NIT Clause 6.18.4 within one month from the date of Award of this contract failing which AAI recover penalty from the running bill amount as mentioned in the said Clause.
10. All points referred above shall be part of the contract.

You are therefore requested to start the work as per terms & conditions stipulated in Tender NIT as per Tender Id 2022_AAI_120463_1.
