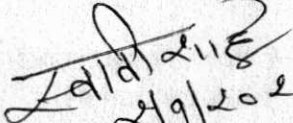

You are requested to comply with all Rules and Regulations of the Shop and Establishment Act, Factories Act, Industrial Dispute Act, P.F., ESIC, Minimum Wages Act, etc and the provisions of any statutory law applicable to the Licensee including other Department of Government and or Local Body or Administration in force from time to time and to the business which the Licensee is allowed to carry on under this Agreement and to the area in which the said premises are located.

5. You are also directed to contact General Manager (ATM)/Co-Ordination In-Charge, Airports Authority of India, DBAI Airport, Nagpur immediately, who will arrange to hand over the site to you.
