Sir,

Please refer to your Bid for E-Tender No. 2022_AAI_123127_1. In this regard, it is hereby intimated that your bid for License for packaged bakery products in SHA at Dehradun Airport has been accepted by the Competent Authority with following terms and conditions: -

1. Period of Concession: The period of concession shall be One (01) Year further extendable by 6 months or till finalization of Master concessionaire, whichever is earlier.

2. Area and Location of the Concession: Area earmarked for the facility is 12.25 sqm in the SHA at Dehradun Airport.

3. Monthly License fee:

a. Monthly License fee of Rs. 7,17,888/- (Rupees Seven lacs Seventeen Thousand Eight Hundred and Eighty-Eight only) **(Plus)**

b. Utility/ Facilitation Charges at 10% of normal space rent (or as may be notified by AAI from time to time, presently normal notified A/c space rent is Rs. 1,080/- Per Sqmtrs. per month. The space rent is subject to annual escalation on 1st April of every year or as decided by AAI from time to time; **+ (plus)**

c. All Government Taxes including GST at applicable rates notified by Government of India/State Government/UT from time to time;

4. Electricity/Water Charges: In addition to above, charges towards consumption of electricity and water, as may be notified/directed by the Authority and at the rate(s) notified from time to time are payable.

5. Advance License Fee: One-month advance license fee of **Rs. 8,48,669/-** (License Fee @Rs 7,17,888/- + Utility charges @ Rs. 1,323/- + GST @ Rs1,29,458/-) **(Rupees Eight Lacs Forty-Eight Thousand Six Hundred and Sixty-Nine only)** is payable in the form of NEFT/ RTGS in favour of Airports Authority of India at Dehradun **within 15 days** from the date of issue of this award letter.

6. Interest on delayed payment: The concessionaire has to make the payment of the License Fees etc. by 25th of same month, failing which interest on delayed payment shall be charged at the rate of 9% per annum from the due date for the delay period of upto 30 days

and if delay is for more than 30 days, then interest rate @ 18% per annum shall be charged from the due date, for entire delay period.

7. **Business Incubation Period** shall mean a period of 15 days from the date of issuance of this award letter. The selected bidder will be under obligation to complete all the formalities conditions of award as specified in this award letter.

8. **Handing Over of Sites:** Site will be handed over upon fulfilment of conditions of award within the stipulated time of business incubation period. If the licensee fails to complete the conditions of award which are pre-requisite for handing over of site, then the gestation period will be deemed to have commenced on 16th day of issuance of this LOIA i.e. immediately after expiry of business incubation period. However, actual handing over of sites shall only be done after completion of all conditions of award.

9. **Gestation Period:** Gestation period of 120 days or actual commencement of commercial operation, whichever is earlier.

10. Security Deposit:

(i) Payment of Security Deposit equal to 04 (four) months of quoted License Fee, i.e., **Rs. 28,71,552/- (Rupees Twenty-Eight Lacs Seventy-One Thousand Five Hundred and Fifty-Two only)** in the form of NEFT/RTGS or BG from a Nationalized / Scheduled bank, **valid upto 06 (six) months** after the expiry of License period, in favour of Airports Authority of India at Dehradun Airport **within 15 days** from the date of issue of award letter.

(ii) Payment of Security Deposit equivalent to 5% of annual license/concession fee, i.e. **Rs. 4,30,733/- (Rupees Four Lacs Thirty Thousand Seven Hundred and Thirty-Three only)** is to be submitted for electricity/ water/telephone etc. in the form of NEFT/RTGS or BG from a Nationalized/Scheduled bank, **valid upto 06 (six) months** after the expiry of Licence period, in favour of Airports Authority of India at Dehradun Airport **within 15 days** from the date of the issue of award letter.

(iv) No interest is payable on security deposit.

11. **License Agreement** is to be executed on a Non-Judicial Stamp Paper (denomination of Rs.100/-) within 15 days from the date of issuance of this award letter. Further, licensee is also instructed to pay the stamp duty charges in accordance with the stamp laws applicable to the state and the licensee shall abide by the same.

12. The necessary Airport Entry Permits to the authorized representative(s) and employees of the concessionaire shall be issued on behalf of Airport Director as per rules/regulations of

BCAS. It shall be responsibility of the Licensee to obtain character verification and other relevant documents for this purpose.

13. All the formalities related to Bureau of Civil Aviation Security (BCAS) i.e., obtaining Provisional Security Clearance/ Security Clearance through e-sahaj portal and submission of Security Programme, are to be strictly adhered to. Necessary assistance/ guidelines, if required may be obtained from the Airport Operator/BCAS in this regard. As per AVSEC order no. 01/2017 dated 28.02.2017, no business establishment is allowed to commence its business in the SRA without Security clearance and its Security program duly approved by BCAS.

14. This Award letter along with other clauses of NIT shall form part and parcel of the License Agreement.

15. All other terms and conditions shall be applicable as per other Clauses of NIT.

You are requested to convey your acceptance along with copy of this Award letter (duly signed by the authorised signatory) within 15 days of issuance of this award letter and also complete other formalities as per para 5, 10 & 11 above, failing which the EMD shall be forfeited and licensee will be debarred from participating in any tender of AAI for a period of one year.
