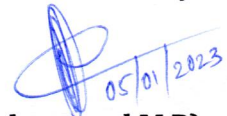

The monthly payments to AAI, Calicut shall be done using Virtual Account Number (VAN) payment system. The AAI User Manual for payment using VAN is enclosed herewith for ready reference.
3	License period	License is awarded for a period of 02 (Two) years extendable by another 06 (Six) months on operational requirements of AAI. The License period commences from the 121 st day from the date of this award letter or from the actual date of commencement of the License, whichever is earlier.

 - b) Business Incubation Period of 30 days from the date of issue of award letter, and Gestation Period of 90 days from the date of expiry of Business Incubation Period i.e. from the 31st day of issue of award letter and expiring on the 120th day from the date of issue of award letter for completion of all post award formalities and commencement of License as per the timelines indicated in NIT.
 - c) Payment of One-month advance License Fee amounting to **Rs.14,19,175/-** (License Fee, CAM charges & GST @ 18%) within Business Incubation Period i.e. within 30 days from the date of award letter.

10. This award letter, NIT and Tender Corrigendum including all terms and conditions mentioned therein will form part and parcel of the Agreement.
11. The License fee shall commence from the 121st day from the date of issue of award letter or from the actual date of commencement of the License, whichever is earlier.
12. A Stamp paper worth Rs.200/- is to be submitted to this Office for executing the Agreement.
