5. **Security Deposit:**
(a) Payment of Security Deposit in the form of DD/PO/ RTGS/NEFT/ Bank Guarantee within 15 days from the date of issuance of award letter, amounting to Four (04) months equivalent License Fee/Concession fee & Common Area maintenance charges (inclusive of Taxes/GST) of the 1st year to AAI as an interest free security Deposit amounting to **INR 2,94,564/- (Rupees Two Lakh Ninety Four Thousand Five Hundred Sixty Four Only)**.

(b) While submitting the documents to BG issuing bank, successful bidder to submit a letter to the issuing bank as per the format mentioned in the Appendix 2 of the annexure K of Notice Inviting E-tender along with details as per clause 5 of "GENERAL INFORMATION AND GUIDELINES" of section of NIT/tender document.

(c) Payment of security deposit in respect of electricity charges amounting to **INR 53,500/- (Rupees Fifty Three Thousand Five Hundred Only)**. The said security deposit will cover SD towards all types of utilities such as Electricity, Water, Data Port, Telephone etc.

- iii. Utility/Facilitation/Common area maintenance Charges at 10% of normal space rent (or as may be notified by AAI from time to time, presently normal notified space rent is **INR 1340/- Per SQM per month** (for A/C) subject to annual escalation of 7.5% p.a. or as fixed by AAI from time to time) for allotted space.
 - iv. All applicable Government Taxes including GST (presently at the rate of 18%) or at the rates declared by Government of India or State Government from time to time.
 - v. Charges for the consumption of the electricity and water consumed for the purpose of use of the said license as becomes due and payable and in accordance with the directions of the Authority and at the rates as fixed by AAI from time to time.
- (d) Airports Authority of India shall raise bill on or before 10th of every month. The concessionaire has to make the payment of license fee etc. by 25th of the same month, failing which interest on delayed payment at the rate of 9 % per annum shall be charged from the due date for delay period of up to 30 days and if delay is for more than 30 days, the interest at the rate of 18 % per annum shall be charged from the due date, for entire delay period.
- (e) The Business Incubation Period, Handing over of sites, Gestation Period, Commencement of Business and Date of Commencement of License Fee / Concession Fee etc. shall be as per NIET / tender document.
