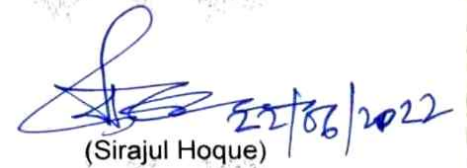

ANNEXURE A
