You are requested to return one copy of it duly acknowledged and signed by authorized signatory on behalf of **Consortium of M/s ETA Engineering Pvt. Ltd & M/s Polycab India Ltd.** on all pages indicating "Unconditional Acceptance" thereof so as to reach the undersigned within one week of the receipt of this letter.
5. You shall ensure full compliance with Tax Laws and Labour Laws of India with regard to this Contract and shall be solely responsible for the same. You shall keep the Employer fully indemnified against your liability of tax, interest, penalty etc. in respect thereof, which may arise.
6. This letter of Acceptance shall be treated as 'Notice of Proceed' and the work shall be completed within **36 months (Thirty Six months)** from date of commencement of work i.e, **01.03.2023**. The Key dates specified in the 'Schedule of Key dates' shall be reckoned from the date of commencement of work.
