1.4 Reason for Rejection:**1) M/s. PN Rathi:**

- Bidder has not submitted Completion Certificate showing executed value related to exclusively for Housekeeping Work only even after TQ-CQ.
- Bidder has not submitted Form-1 & Form-2 even after TQ-CQ.

2) M/s. Singh And Sons Infotech Private Limited:

- Bidder is a Startup & has submitted startup certificate no. DIPP55767 registered under Industry domain of Professional & Commercial Services and Sector Domain of "Business Support Supplies". The industry Domain of the bidder is same as specified

for Technical Bid qualifications but the Sector Domain is not complying with the qualification criteria.

3) M/s. Urmila International:

- Bidder has submitted 02 nos. of partial completion certificates for the work “Mechanical Cleaning of Railway Coached” & “Onboard Cleaning of Railway Coaches”. However, our BEC is for experience in housekeeping /sanitation/upkeep services in offices/ Guest house/ Training Institute of any Govt./ Semi Govt./ PSU/ MNC/ Pvt. Company. Since the area of experience of the bidder doesn’t match with our qualification requirement, therefore there is no option to accept the bid.

4) M/s. Validate Services:

- Bidder is a Startup & has submitted startup certificate no. DIPP40291 registered under Industry domain of Human Resources and Sector Domain of Talent Management which are not the same domains specified for Technical Bid qualifications.
