Further bidder has not submitted requisite documents inspite of query sent through mail (P/152-208)

Champak Steel and Engg. Co: Bidder has not submitted Company Registration / ISO certificate / NSIC or any other relevant document as a proof of it being a manufacturer. It has also not submitted Authorization certificate from manufacturer as a proof of it being an Authorized distributor / dealer / stockiest of manufacturer and Company Registration/ ISO certificate/ NSIC or any other relevant document as a proof of principal being manufacturer. Further bidder has not submitted requisite documents in spite of query sent through mail.

Eckhardt Steel and Alloys: Bidder has submitted copy of DNV-GL certificate as a proof of principal being manufacturer. However, it has not submitted authorization certificate from manufacturer as a proof of it being an authorized distributor / dealer / stockiest of manufacturer. Further bidder has not submitted requisite documents (BEC TECHNICAL) in spite of query sent through mail

Ramdev Steel India: Bidder has not submitted copy of any single PO having minimum order value of 6.18 lakhs.
