Sub: Work Order for Annual repair & maintenance of F.J.G-XXI at Farakka during the year 2021-22.

Sir,

Kindly refer to e tender no IWAI/KOL/MM/76/21-22/Pontoon for Annual repair & maintenance of F.J.G-XXI at Farakka; we are pleased to award a work order to M/s. SIM Company. at a total cost of Rs. 3,36,200/- excluding GST (Rupees Three Lakh Thirty Six Thousand Two Hundred only) as per enclosed bill of quantity in accordance with the tender terms & conditions.

The total cost of work shall be Rs 3,36,200/- excluding GST and cost of materials on actual plus 10 % basis as per item wise rate mentioned in the enclosed BOQ subject to variation of quantity of work actually executed and certified by the EIC,. The above-mentioned total cost is inclusive of taxes, duties and other levies etc, as specified in tender. The payment shall be made on submission of bill after certification of the E.I.C for the actual quantity executed. The work shall be completed within 30 (Thirty) days from the date of receipt of work order. If any additional work is to be carried out, completion period shall be extended accordingly.

You are requested to deposit Rs. 33,620/- (Rupees Thirty Three Thousand Six Hundred Twenty only) being the 10% of the contract value as performance guarantee for the due fulfillment of the contract in form of Demand Draft on any Nationalized Bank or Scheduled Bank of India in favor of "Inland Waterways Authority of India Fund" payable at Kolkata within 15 days of the issue of the work order as per terms & conditions of the tender document. Further, Security Deposit shall be deducted from each running bill @ 10 % of the gross amount of bill till the security deposit amount along with EMD becomes 5 % of total contract value.

In case of delay in completion of the repair work of the vessel and delivery thereafter, liquidated damages as per the Clause no. 35 will be applicable @ 1.5% per

month of delay for delay of work to be computed on per day basis subject to a maximum 10% on the total value of the contract.

A list of the additional work which are considered necessary as per recommendation of the EIC and or those which are directed during the course of repairs for satisfactory completion of repairs and subsequent commissioning of vessel should be prepared jointly by EIC and contractor. Thereafter, contractor shall furnish quotation for those items of work for which rate would be derived from the agreement or afresh as the case may be in force along with extra time required for completion of all the additional work. The rate for the additional work shall be approved as provided in clause No. 12 of Technical & Special Conditions of contract and clause no. 16 of the General Condition of contract for execution.

The work executed all items of work attended and spare etc supplied by the contractor shall have Guarantee period of minimum 6 months or manufacturers warrantee whichever is more from the date of delivery of the pontoon after repair.

An agreement shall be entered between this Authority and yours in the approved format within ten days from the date of receipt of work order. You are requested to attend this office with non-Judicial stamp papers of Rs 100/- for signing of contract agreement.

It is requested to convey your acceptance for this work order by signing the copy of this letter immediately.

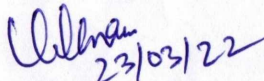

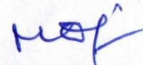

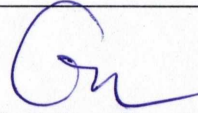

Recommendation : From the above comparative statement it is found that M/s SIM Company has quoted the lowest rate i.e Rs 3,36,200/-, which is 45.02 % lower than our estimated cost of Rs 6,11,550/- plus cost of material on actual plus 10 % basis. Hence, it recommends by TEC to place the work order to M/s SIM Company at the total cost of Rs 3,36,200/- only excluding GST plus cost of material on actual plus 10 % basis.
