2. **PAYMENT ON ACCOUNT**

- i) 80% (Eighty percent) of the contract value will be paid against Supply of Goods shall be released after 30 days of the successful Delivery of the instruments/Equipment as per Schedule of Requirements. For the equipment supplied at various locations, the supplier will furnish the invoice for supply of goods duly certified by the Officer-in-Charge of IWAI for supply of goods. The respective Officer-in-Charge of the authority or their representative would certify the delivery challan and invoice within 15 days of completion of delivery.
 - ii) 20% (Twenty percent) of the contract value will be paid against installation, training (if specified) and commissioning. For the equipment tested & commissioned at various locations, the supplier will furnish the installation & commissioning report duly certified by the Officer-in-Charge of IWAI for installation & commissioning. The respective Officer-in-Charge of the authority or their representative would certify the installation & commissioning report within 15 days of completion of installation & commissioning.
 - iii) Performance Guarantee and Security Deposit will be released on expiry of warranty period of 12 months subject to Clause 4.4 in general conditions of contract or final settlement of all claims of the purchases under the terms of contract whichever occurs later.
 - iv) Part payment will be allowed against the contract prices for individual site and it would be location-wise for the particular item.
3. A draft Performance Guarantee form is enclosed at Encl-1. BG should be directly forwarded by the issuing bank under Registered AD Post, to IWAI.
