Sub: Work Order for Dry-dock repair of IWAI Pontoon C.P.G-I at Howrah regd.

Sir,

Kindly refer to e tender no IWAI/KOL/MM/76/Pontoon17-18 for Dry-dock repair of C.P.G-I at Howrah, we are pleased to award a work order to M/s Milan Marine Service at a total cost of Rs. 13, 70,786/- (Rupees Thirteen Lakh Seventy Thousand Seven Hundred Eighty Six only) as per enclosed bill of quantity in accordance with the tender terms & conditions.

The total cost of work shall be Rs 13,70,786/- as per item wise rate mentioned in the enclosed BOQ subject to variation of quantity of work actually executed and certified by the EIC.. The above-mentioned total cost is inclusive of taxes, duties and other levies etc, as specified in tender. The payment shall be made on submission of bill after certification of the E.I.C for the actual quantity executed. The work shall be completed within 45 (forty five) days from the date of placement of the pontoon. If any additional work is to be carried out, completion period shall be extended accordingly.

You are requested to deposit Rs. 1, 37,078/- (Rupees One Lakh Thirty Seven Thousand Seventy Eight only) being the 5% of the contract value as performance guarantee for the due fulfillment of the contract in form of Demand Draft on any Nationalized Bank or Scheduled Bank of India in favor of "Inland Waterways Authority of India Fund" payable at Kolkata within 15 days of the issue of the work order as per terms & conditions of the tender document. Further, Security Deposit shall be deducted from each running bill @ 10 % of the gross amount of bill till the security deposit amount along with EMD becomes 5 % of total contract value.

In case of delay in completion of the repair work of the vessel and delivery thereafter, liquidated damages as per the Clause no. 35 will be applicable @ 1.5% per

month of delay for delay of work to be computed on per day basis subject to a maximum 10% on the total value of the contract.

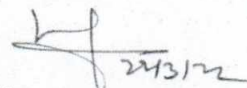
A list of the additional work which are considered necessary as per recommendation of the EIC and or those which are directed during the course of repairs for satisfactory completion of repairs and subsequent commissioning of vessel should be prepared jointly by EIC and contractor. Thereafter, contractor shall furnish quotation for those items of work for which rate would be derived from the agreement or afresh as the case may be in force along with extra time required for completion of all the additional work. The rate for the additional work shall be approved as provided in clause No. 12 of Technical & Special Conditions of contract and clause no. 16 of the General Condition of contract for execution.

The work executed all items of work attended and spare etc supplied by the contractor shall have Guarantee period of minimum 6 months or manufacturers warrantee whichever is more from the date of delivery of the pontoon after repair.

An agreement shall be entered between this Authority and yours in the approved format within ten days from the date of receipt of work order. You are requested to attend this office with non-Judicial stamp papers of Rs 100/- for signing of contract agreement.

It is requested to convey your acceptance for this work order by signing the copy of this letter immediately.
