

**Recommendation of TEC on Technical bid of the E-tender for "Annual afloat repair 04 nos. IWAI vessels viz CSD Mandovi, PT Bhagat Singh, SL Kosi & SL Subansiri at IWAI, Guwahati"**

- (iv) **M/s Milan Marine Service, Kolkata:** The firm has participated in e-tender of 1 no. vessels i.e., PT Bhagat Singh.
- (v) **M/s Ghosh Enterprise, Kolkata:** The firm has participated in e-tender of 2 nos. vessels i.e., for PT Bhagat Singh & CSD Mandovi.

3. Observations of TEC

3.1 Detailed statement of the bid documents submitted / uploaded by the above bidders viz a viz tender criteria have been prepared and placed as Annex - I. From the detailed statement, 3 (three) bidders, as mentioned below, have adequate experience but have not uploaded some mandatory documents like audited balance sheet, documents of legal constitution of the present firm which differ from past firm, tender document stamp & signed by the firm, current Solvency certificate, details of tools & plant etc.

- (ii) M/s Krishna Engineering Works & Consultants, Merrut, UP
- (iii) M/s A.C. Roy Shipbuilder Pvt. Ltd. Kolkata

4. Recommendation of TEC

4.1 TEC recommends that keeping in view of the three firms mentioned under 3.1, are having adequate experience, letter / email may be issued for collecting the mandatory documents via e-mail on (or) before 3.8.2022 @ 1400 hours for more competitive bids. Non submission of these mandatory documents within the stipulated time may result in disqualification of their Technical bids.

4.2 In this regard vide this office e-mail dated 1.8.2022, the firms mentioned under 3.1 was requested to submit mandatory shortfall documents for qualifying technically. Accordingly, all the 3 (three) firms have submitted the mandatory shortfall documents by trailing e-mail dated 2.8.2022 has fulfilled the required criteria for eligibility.

4.3 TEC recommends that 5 (five) firms i.e., M/s Das Consultancy & agency Service, M/s Krishna Engineering Works & Consultants, M/s A.C. Roy Shipbuilder Pvt. Ltd, M/s Milan Marine Service & M/s Ghosh Enterprise are having adequate experience & submitted all the mandatory documents mentioned under 4.2 and therefore technically qualified.

4.5 TEC recommends to open the financial bid of technically qualified firm as detail below:
