

Recommendation of TEC on Technical bid of the E-tender for "Dry Dock repair 3 nos. IWA vessels viz SL Lohit, SL Barak & AB Rajrambha at IWA, Guwahati"

Reference above, for opening of financial bid of dry docking repair of 3 nos. vessel, the TEC recommendation of technical bid has prepared as follows:

Observations of TEC

3.1 The 2 (Two) nos. firms have participated in E- Tender for dry docking repair for 3 (Three) nos. vessels namely SL Lohit, SL Barak & AB Rajrambha. A detailed technical comparative statement of the bid documents submitted by the above bidder viz a viz tender criteria have been prepared and placed as Annex-1. From the detailed comparative statement, it has been observed that M/s. Das Consultancy & Agency Service has submitted all the relevant documents as per tender criteria and on the other hand M/s. Kib-Butz Associates have not submitted mandatory documents such as Bank Solvency and balance sheet for the 2020-21 for qualifying technically.

Recommendation of TEC

4.1 TEC recommends that keeping in view the firm i.e M/s. Kib-Butz Associates, Guwahati having adequate experience, letter/email may be issued for collecting mandatory documents via email on (or) before 29.8.2022 @ 1400 hours for more competitive bids. Non submission of these mandatory documents within the stipulated time may result in disqualification of their technical bids.

4.2 In this regard vide this office e-mail dated 26.8.2022, the firms mentioned under 4.1 was requested to submit mandatory shortfall documents for qualifying technically. Accordingly, the firm i.e M/s. Kib-Butz Associates, Guwahati has reported by trailing e-mail dated 30.8.22 that the firm could not submitted the mandatory documents mentioned under 3.1. Hence the firm i.e M/s. Kib-Butz Associates, is disqualified for all 3 (three) nos. vessels.

4.3 Further TEC recommends for cancel the tender as M/s. Das Consultancy & Agency Service is the single bidder which is technically qualified.
