

TEC RECOMMENDATION

As per the NIT, the tender documents were to be submitted on line by the bidder to Director, IWAI, Kolkata on or before 21.08.2022 upto 15.00 hrs. and to be opened on 22.08.2021 at 15.30 hrs. Accordingly, the technical bids opened of 22.08.2022 at 15.30 hrs. After opening of technical bids, it is observed that following bidders have participated in this tender for different location which is as given below:

1/4) M/s Anjan Kumar Ghosh- (Participated for Farakka, Swaroopganj & Kolkata)

2/4) M/s Das Enterprises- (Participated for Farakka, Swaroopganj, Kolkata & Haldia)

3/4) M/s Giasuddin Sk - (Participated for Farakka, Swaroopganj & Kolkata)

4/4) M/s Shankar Lal choudhary- (Participated for Swaroopganj)

On scrutiny of the document submitted above mentioned bidders TEC observed the following :-

1/4)	M/s Anjan Kumar Ghosh	On scrutiny of the documents submitted by M/s Anjan Kumar Ghosh, it is observed by TEC that, they have submitted all required document as per technical parameters mentioned in the tender document and TEC recommends them as technically qualified bidder for Hire of vehicle for Farakka, Swaroopganj & Kolkata.
2/4)	M/s Das Enterprises	On scrutiny of the documents submitted by M/s Das Enterprises, it is observed by TEC that, they have submitted all required document as per technical parameters mentioned in the tender document and TEC recommends them as technically qualified bidder. However, as per technical parameters of tender document bidders has to submit Bank Solvency for an amount of Rs.9.20 lakh (i.e Haldia Rs.3.9 lakh + Farakka Rs. 2.5 lakh + Kolkata Rs.2.8 lakh) & where as the bidder has to submitted bank solvency for an amount of Rs.6.0 lakh which only fulfill the bank solvency criteria for Farakka, Kolkata & Swaroopganj only. Hence, TEC recommends to ask shortfall for required bank solvency as mentioned above.
3/4)	M/s Giasuddin Sk	On scrutiny of the documents submitted by M/s Giasuddin Sk, it is observed by TEC that, he has submitted all required document as per technical parameters mentioned in the tender document except Proof of experience and work done certification for similar type of work and TEC recommends to ask shortfall for Proof of experience and work done certification for similar type of work.
4/4)	M/s Shankar Lal choudhary	On scrutiny of the documents submitted by M/s Shankar Lal choudhary, it is observed by TEC that, he has submitted all required document as per technical parameters mentioned in the tender document and TEC recommends them as technically qualified bidder for Hire of vehicle for Swaroopganj.

Hence, considering above TEC recommends to ask shortfall from M/s Das enterprise to required bank solvency and from M/s Giasuddin Sk to submit required Proof of experience & work done certification for similar type of work to be submitted in online within 19.09.2022 upto 14:00. After submission of the shortfall document by M/s Das Enterprise and M/s Giasuddin Sk, TEC will finalize the recommendation.
