

**Recommendation of TEC on Technical bid of the E-tender for "Deployment of technical and supporting Manpower (Marine & Survey Wing) under RO, IWAI, Guwahati on Outsource basis during 2022-23"**

3. Observations of TEC

3.1 The 2 (Two) nos. firms have participated in E- Tender for Deployment of Technical and Supporting Manpower (Marine & Survey Wing) under RO, Guwahati, on Outsource basis. A detailed technical comparative statement of the bid documents submitted by the above bidders viz a viz tender criteria have been prepared and placed as Annex-1. From the detailed comparative statement, it has been observed that M/s. Dolphin Security and Advertising, Guwahati has submitted all the relevant documents as per tender criteria and on the other hand M/s. HRD Commercial and Industrial Security Force Pvt. Ltd have not submitted mandatory documents for qualifying technically. The following documents are as follows:

- i) Current Bank Solvency certificate within 6 months
- ii) Integrity agreement duly stamped & signed.
- iii) Original Tender document duly stamped & signed.

Recommendation of TEC

4.1 TEC recommends that keeping in view the firm i.e M/s. HRD Commercial and Industrial Security Force Pvt. Ltd having adequate experience, letter/email may be issued for collecting mandatory documents via email on (or) before 8.9.2022 @ 1400 hours for more competitive bids. Non submission of these mandatory documents within the stipulated time may result in disqualification of their technical bids.

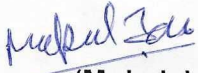
