3. Observations of TEC

3.1 Detailed statement of the bid documents submitted / uploaded by the above three bidders viz a viz tender criteria have been prepared and placed as Annex - I. From the detailed statement, TEC observed that out of the above mentioned 3 (three) bidders, one bidder (i.e. M/s Dolphin Security & Advertising) had uploaded all the requisite/mandatory documents and they may be qualified in their Technical bid.

3.2 Further, 2 (two) bidders viz M/s HRD Commercial & Industrial Security Force Pvt. Ltd. and M/s Orient Integrated Facility Management Pvt. Ltd. are found to have not uploaded some mandatory documents like Letter of bid, signed and sealed tender document, Litigation history, Proof of office in the tender calling authority city, Bank solvency not older than 6 months, Undertaking for submitting labour license within 21 days of issuance of letter of acceptance and undertaking that the employees will not be paid less than the remuneration notified in the tender as per clause 3.7 of Section II: ITB, Proof of completion at least one of the works in NE India / Assam as per clause 3.8 of Section II: ITB etc.

3.3 In view of the above, TEC recommended to qualify M/s Dolphin Security & Advertising and further, TEC recommended to ask for the shortcomings from the remaining bidders as mentioned at para 3.2. The recommendation of TEC was approved by the Competent Authority and also the shortcomings of one bidder viz M/s HRD Commercial & Industrial Security Force Pvt. Ltd. have been received by 7th November 2022 whereas another bidder viz M/s Orient Integrated Facility Management Pvt. Ltd. did not send one requisite / mandatory document from their list of shortcomings, thereby, leading them to disqualification. An updated statement of bids is attached as Annex-II.

4. Recommendation of TEC

4.1 TEC finally recommends that except M/s Orient Integrated Facility Management Pvt. Ltd., remaining two bidders may be considered in qualification of their Technical bids and their Financial bids may be opened.
