

Recommendation of TEC on Technical bid of the E-tender for "Deployment of Technical and Supporting Manpower (Marine & Survey Wing) under RO, IWAI, Guwahati on outsource basis during 2022-23"

3. **Observations of TEC**

- 3.1 Detailed statement of the bid documents submitted / uploaded by the above bidders viz tender criteria have been prepared and placed as Annex – I. From the detailed statement, 2 (two) bidders, as mentioned below, have adequate experience but have not uploaded some mandatory documents such as:

(i) M/s Orient Integrated Facility Management Pvt. Ltd., Mumbai

The firm has not submitted the valid Bank solvency certificate which is older than 6 months i.e. dtd. 29.1.2022, Valid Declaration By Bidder which is older than 6 months i.e. on dtd. 8.2.2022, Proof of Office in the Tender calling authority city not submitted, Power of Attorney: Have to submit for Supply and Deployment of Technical & supporting manpower for (Marine & Survey Wing) and Letter of bid not submitted.

(ii) M/s HRD Commercial & Industrial Security Force Pvt Ltd, Karimganj

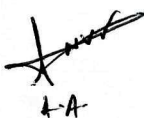
The firm has not submitted the Letter of bid, Tender Documents and List of Litigation history.

(iii) M/s A S Private Security Service, Silchar

The firm does not have adequate experience in similar works and also has not submitted all mandatory documents like original tender document, Proof of Office in the Tender calling authority city not submitted, list of Litigation History etc.

3.2 Further, among the 04 nos. bidders; only 1 (one) bidder, as mentioned below, have adequate experience and has submitted all mandatory documents.

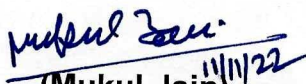
(i) Dolphin Security & Advertising, Guwahati

4. Recommendation of TEC

4.1 TEC on 5.11.2022 has recommended that even though the mandatory documents are collected from 3 (three) firms mentioned under 3.1, are having adequate experience, letter / email shall be issued for collecting the mandatory documents via e-mail on (or) before 10.11.2022 @ 1400 hours. Non submission of these mandatory documents within the stipulated time may result in disqualification of their Technical bids.

4.2 In this regard, vide this office email dated 8.11.2022, the firms i.e., mentioned under 3.1 were requested to submit mandatory shortfall documents for qualifying technically. Accordingly, the firms have submitted the mandatory shortfall documents by trailing email dated 10.11.2022 has fulfill the required criteria for eligibility except M/s Orient Integrated Facility Management Pvt. Ltd., Mumbai & M/s A S Private Security Service, Silchar.

4.3 Hence, TEC recommends that, **2 (two)** firms i.e., M/s Dolphin Security & Advertising, Guwahati & M/s HRD Commercial & Industrial Security Force Pvt Ltd, Karimganj are having adequate experience & has submitted all mandatory documents and therefore technically qualified and open the financial bid.
