E- tender no. IWAI/WB/ArthGanga (NW-1)/T-03/2022 for subject work was published in on IWAI website and CPPP portal on 25.10.2022. Last date of receipt of bid and opening of technical bid was 31.10.2022 at 15.00 hrs and 01.11.2022 at 15.30 hrs respectively. Following two firms have submitted their bid online as:

1. M/s Kanubabu Enterprises, Varanasi
2. M/s Grassroot Events and Avertising Pvt. Ltd., Assam

Technical bids of the above firms were opened online on 01.11.2022 at 15.30 hrs by the TEC. The firms have been submitted the required documents as per tender the comparative statement of technical bid is given at Annex-I. As per the tender "Out of the total 37 marks allotted for technical bid, those bidders who achieve 22 marks & above would qualify for the final evaluation of their Price bid. Those who do not achieve the same, will not qualify for the price bid stage". 70 % weightage for obtaining marks and 30 % weightage for quoting price will be the criteria used for final selection of firms. However, the marks sheet for technical bid qualification for both bidder are attached at Annex - II.

Technical Evaluation Committee (TEC) has evaluated all the document submitted by both bidder which are in order as per the tender document. Hence, the TEC recommends to technically qualifying the both bidders.
