

FINANCIAL BID EVALUATION SUMMARY

Sub: E-tender for "Dry-Docking repair works SL Pamba at Yard in Kochi During the year 2022-23".

The financial bids of 3 nos. technically qualified bidders namely 1) M/s Unotech Marine Engineering & Services Pvt Ltd Kochi, 2.) M/s Maretek India Pvt Ltd, Kochi and 3.) M/s Cochin Marine Engineering Kochi were opened on 17.12.2022, 16.00 hrs.

As per the financial evaluation of 03 no financial bids (E-tender) by the TEC, it is observed that M/s Maretek India Pvt Ltd, Kochi (L1) has quoted the amount (including cost of spare parts on actual +10% of Rs.1,20,000) Rs. 14,17,350/- excl GST (Rupees Fourteen Lakh Seventeen Thousand Three Hundred and Fifty Only), which is less than 4.3 % of Departmental estimated cost being the L1 bidder and M/s Unotech Marine Engineering & Services Pvt Ltd Kochi, has quoted the amount (including cost of spare parts on actual +10% of Rs.1,20,000) Rs. 14,81,600/- excl GST (Rupees Fourteen Lakh Eighty-One Thousand Six Hundred Only), which is less than 3.2% of Departmental estimated cost being the L2 bidder and the other Bidder M/s Cochin Marine Engineering Kochi, has quoted the amount (including cost of spare parts on actual +10% of Rs.1,20,000) Rs. 14,48,600/- excl GST (Rupees Fourteen Lakh Forty-Eight Thousand Six Hundred Only), which is less than 2.2% of Departmental estimated cost being the L3 bidder.

Hence, the TEC recommends to issue the work order to M/s Maretek India Pvt Ltd, Kochi (L1bidder) with the quoted amount Rs. 14,17,350/- Only excl (18% GST as applicable) and provision for an amount of Rs. 1,20,000/- for procurement of spare parts on actual +10% basis for the mentioned items sl no's 6.1, 7.1,8.1, 9.1, 11.1, 27.1, 28.1 after submitting of original invoice / bills against procurement of the same as per tender clause no: 8 (of technical specification and special condition of contract) for undertaking Dry docking repair works of SL Pamba at Yard in Kochi.
