The bidders have been intimated to submit the missing documents on or before 05.01.2023. Accordingly, the bidders M/s. Group 7 Guards India Pvt. Ltd, Mumbai & M/s. Oriental Integrated Facility Management Pvt. Ltd, Mumbai, submitted the documents before the allotted time, but on conformation of the Bank Solvency Certificate, Bank of Baroda, Nadesar branch, Varanasi is confirmed that the certificate not issued to the M/s. Group 7 Guards India Pvt. Ltd, Mumbai.

Final Evaluation of Technical Bid done by the TEC on 05.01.2023 has observed and considered M/s. Oriental Integrated Facility Management Pvt. Ltd, Mumbai & M/s. Seaworld Shipmanagement Services, Ernakulam technically Qualified & the other bidder M/s. Group 7 Guards India Pvt. Ltd, Mumbai have technically not qualified. Therefore, the TEC recommends to open the finance bid of Technically Qualified bidders.
