Based on the recommendations of the tender committee, Project Director, PIU Nirmal letter vide reference 6th cited and in light of the powers delegated vide no.NHAI Policy Matters - Technical (209/2016), dated 02/08/2016, the approval of the Competent Authority is hereby conveyed to the lowest bid quoted by M/s.Sri Balaji Constructions, i.e., for Rs.3,55,03,577.65 (Rupees Three Crore Fifty Five Lakh Three Thousand Five Hundred Seventy Seven and Sixty Five Paise only) which is 5.00% below the estimated value of Rs.3,73,72,187/- (excluding GST & Royalty) for carrying out the subject work.

3. As per recommendation of the tender committee and as per Cl.33, Section-II of RFP, PD shall obtain Bank Guarantee towards Performance Security from the L1 bidder. Accordingly, PD may conclude the Agreement at his level.

4. Further, Project Director is advised to undertake frequent and regular inspection of above project and issue inspection notes so as to ensure requisite quality standards as per NHAI Policy Guidelines No.15.8/2021, dated 15/01/2021.
