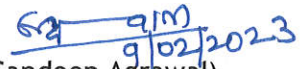

It is requested to confirm your acceptance of this Letter of Award within 7 days and to furnish an unconditional Bank Guarantee as per details mentioned in Clause 7 of Section-2 of RFP (LOI), for an amount equivalent to 3% of the Contract value i.e. Rs. 17,94,331 (Rupees Seventy Lakh(s) Ninety Four Thousand Three Hundred Thirty One Only) towards Performance Security within 15 days of issue of LOA. This Bank Guarantee shall be as per relevant format specified in Appendix-H of Draft Contract Form and shall be valid up to 2 months beyond the expiry of the Contract period.

7. Upon submission of required Performance Security, you are required to sign the Contract Agreement with NHAI on a date & time convenient to both parties within 15 days of receipt of valid Performance Security. Thereafter, the services shall commence immediately within one month from the date of signing of Consultancy Agreement.
