As per clause 2.28 vide pg. no.21 of RFP and in which it states that "After selection, a Letter of Award (the "LOA") shall be issued, in duplicate, by the Authority to the Selected Applicant and the Selected Applicant shall, **within 7 (seven) days** of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof."

9. Further, as per clause 2.20.2.1 vide pg. no.19 of RFP and in which it states that "Within 30 (thirty) days of issue of Letter of Acceptance, the selected Bidder shall furnish to the Authority an irrevocable and unconditional guarantee from a Bank in the form set forth in Appendix-I (the "Performance Security") for an amount equal to **03% (Three percent)** of its Bid Price. Bank guarantee shall be issued by nationalized bank, or a Scheduled Bank in India having a net worth of at least Rs.1,000 crore (Rs. one thousand crore), in favour of the Authority in the format at Appendix-I (the "Bank Guarantee"). This Bank Guarantee shall be transmitted through SFMS Gateway to NHAI's Bank."

10. As per the Minutes, the Bid Evaluation Committee has recommended for issue of LOA to M/s. **JAIMAN Construction and Consultants LLP.** for the quoted amount of **Rs.50,00,000/-**.

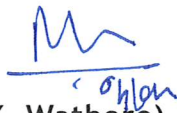
