This has reference to your technical and financial proposal submitted for the above mentioned project.

2. The NHAI has accepted your proposal for a contract price of Rs 97850/- excluding GST (Rs. Ninety Seven Thousand eight hundred fifty only) for providing, running & maintenance of commercial Vehicle Innova (Crysta) or Equivalent as per terms & conditions for Travelling upto 3500Km & per month with Rs 15/- excluding GST (Rs Fifteen only) for extra Km. Charge- per Km and Rs 66550/- excluding GST (Rs Sixty six thousand five hundred fifty only) for Providing, running & maintenance of commercial Vehicle (Bolero/Scorpio or Equivalent) as per terms & conditions for Travelling upto 3000Km. & per month with Rs 14/- excluding GST (Rs Fourteen only) for Extra Km. Charge- per Km. However, Monthly payment of Innova shall not exceed the amount quoted for Innova vehicle based on the extra Kms, if any.

3. As per RFP, Contract period is for 2 year which will be extended for one more year as per fulfilment of provision of RFP. As per clause 3 of Section-II of RFP, It is requested to furnish performance security deposit Rs.4,36,860/- (for 2 years of contract period) in form of demand draft from any nationalized/scheduled bank in favour of "National Highways Authority of India" payable at Rajkot Gujarat within 10 days from issuance of this LOA. On failure submission of the same within stipulated time period, action will be initiated as per provisions of RFP.
