In case of failure of submission of Performance Security, within the time period, the award shall be deemed to be cancelled/ withdrawn and bidder shall be suspended from participation in the tendering process for the works of MoRTH / NHAI / NHIDCL and works under other Centrally Sponsored Schemes, for a period of one year from the bid due date of this work.
