2.5 The technical evaluation has been carried out as per Para 2.21- D - Evaluation Process of Section-2 of Instructions to Applicants of RFP. Details of the technical evaluation sheet is enclosed **Annexure - A.**

2.6 The Committee observed the following:

2.6.1 Details of Key Personnel proposed during empanelment by the Agencies:

The Key Personnel proposed by the above firms are as per the empanelment communicated by NHAI HQs vide Circular No. 12.21/2020, Dt.19.06.2020 & NHAI/RSC/2020/NEWEMPANELMENTSAFETYCONSULTANT-Part (1)/E-62062 dated 24.08.2021 and details are as under:

2.6.3 As per Clause 2.14.3 of Section - 2: Instructions to Applicants, "In case it is found during the evaluation or any time before signing of the Agreement or after its execution and during the period of subsistence thereof, that one or more of the eligibility conditions have not been met by the Applicant

or the Applicant has made material misrepresentation or has given any materially incorrect or false information, the Applicant shall be disqualified forthwith."

2.6.4 As per Clause 2.1.4.1 of Section - 2: Instructions to Applicants, "It is necessary that the applicant shall retain the team proposed at the time empanelment. However, in case of non-availability of Key Personnel in bidding or subsequent stages, the empanelment of the team/firm shall be deemed to be cancelled. The proposals of firms/applicants submitting Key Personnel other than empanelled team shall not be considered."

2.6.5 As per further Clause 2.1.4 of Section - 2: Instructions to Applicants, a firm must have at least the team of two key personnel (i.e. Sr. Road Safety Auditor & Team Leader & Traffic Planner) each of age not more than 65 Years.

2.6.6 During evaluation of the firm M/s. Techmodec Consultants Pvt. Ltd (Team-2) it has been observed that the empanelled Key Personnel Mr. Sita Ram Sharma for the Position of Sr. Road Safety Auditor & Team Leader age was found to be more than 65 years and in submission of Form-6: Details of Safety Consultancy Projects in hand of the proposed Key Personnel the firm has Mentioned that the Details of Safety Consultancy Projects in hand of the proposed Key Personnel as Not Applicable (N/A). Hence, in connection to the Clauses mentioned above it was decided by the evaluation committee to consider the firm as Non-Responsive.

2.6.7 Further as per Clause 2.20.1.1 of Section - 2: Instructions to Applicants, "Any Bid accompanied by the Bid Security shall be rejected by the Authority as Non- Responsive.

2.6.8 During evaluation of the firm M/s. Sphere Infratech Consultancy Pvt. Ltd it has been observed that the firm didn't furnished the payment of Bid Security of Rs.25,000/-. Hence, it was decided by the evaluation committee to consider the firm as Non - Responsive and carry out Financial Evaluation for remaining four (4) firms as detailed below:

3. In view of the above, the Committee observes that the ~~two~~^{three} firms are responsive.

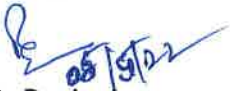
4. In light of the above, the Committee recommends the following for approval of the Competent Authority:
