Minutes of Meeting dated 11.05.2022 held at PIU, Warangal for Opening and Evaluation of Technical Bids for the work of "Providing High-mast Lighting at Intersections as road safety measure on Hyderabad Yadgiri section of NH 163 in the State of Telangana".

The estimate for "Providing High-mast Lighting at Intersections as road safety measure on Hyderabad Yadgiri section of NH 163 in the State of Telangana" was approved by RO, NHAI, Hyderabad vide letter no. NHAI/RO-HYD/11021/1/Hyd-Yad/6/COS/607 dated 14.06.2021 amounting to **0.60 crores (inclusive of all taxes)**, with directions to invite the tenders and submit them for further action.

2. Accordingly, NIT was released vide NIT No. NHAI/PIU-WGL/Road safety/2022/274 dated 21.02.2022 and hosted in e-tender portal of NHAI i.e. <https://nhai.eproc.in>. but the tender was cancelled because of Zero bidder participation.
3. Again 2nd call tender was invited vide NIT No. NHAI/PIU-WGL/Road safety/2022/471 dated 28.03.2022 and hosted in e-tender portal of NHAI i.e. <https://nhai.eproc.in>.
4. The schedule of receipt of Bids is as follows.

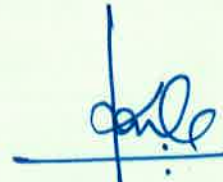
