

Minutes of Meeting of Tender Evaluation Committee (Technical Evaluation) dated 10.08.2022 for the work of

**"Repair, Rehabilitation & Strengthening of damaged portions of Major Bridge Across Thamiraparani river at Km 38+800 LHS on Tuticorin- Tirunelveli section of NH138 (old NH 7A) in the State of Tamil Nadu (2<sup>nd</sup> Call)"**

1. Regional Office invited bids vide Tender ID 2022\_NHAI\_111607\_2 under 2<sup>nd</sup> call for the work of "Repair, Rehabilitation & Strengthening of damaged portions of Major Bridge Across Thamiraparani river at Km 38+800 LHS on Tuticorin - Tirunelveli section of NH138 (old NH 7A) in the State of Tamil Nadu" with an estimated cost of Rs.2114.00 lakhs/- (Excluding GST).

2. A Committee has been constituted with the following members.

i. Shri.C.Raghul, Manager (Tech.,) Regional Office, Madurai (A/C), Convenor

ii. Shri. T.Velraj, DGM (Tech.,) PD PIU - Tuticorin (A/C), Member

iii. Shri. M.S.Pandian, DGM (Tech.,) PD PIU - Karaikudi, Member

iv. Shri.S.Syed Dawood Mian, Asst. Manager (Finance), RO Madurai, Member

3. Last Date of submission of bids was on 03.08.2022 and Technical bid opening was scheduled on 04.08.2022. As per MoRTH Circular No.RW/NH-37010/4/2010-EAP (Printing) Vol.IV dated: 30.04.2020, evaluation of bids can be carried out with the available scanned copy of documents as per RFP requirement. However, successful bidder has to submit the Original Documents physically with the concerned authority before issue of LOA.

4. The bids received through e-Tender portal were decrypted and opened. Total 02 Bids were received. The financial instruments furnished by bidders towards Bid Document Fee and EMD were handed over to the accounts division and they confirmed validity of BGs furnished by the bidders and deposited DDs into NHAI Account.

5. The committee evaluated the bids on 10.08.2022 based on scanned copies of documents submitted through e-Tender Portal. The Technical Evaluation is furnished vide (Annexure - A). A Summary of the same is as hereunder.

6. Based on Initial Technical Evaluation, committee qualifies and recommends for admitting the 2 bids for detailed technical evaluation by providing technical scores. The Committee provided the Technical scores as per the procedure specified for evaluation of bids in section 2 Clause 23 of RFP.

7. As per section (2) Cl.23 of RFP A two-stage procedure will be adopted in evaluating the proposals: (i) a technical evaluation, which will be carried out prior to opening any financial proposal; (ii) The technical proposal should score at least 70 points out of 100 to be considered for financial evaluation, however, the procurement shall be made on least cost based selection among the Contractors (as per below produced table for Technical Evaluation Criterion) and meeting non-conflict and other eligibility requirements, short-listed after technical evaluation.

8. Accordingly, the committee evaluated the bids and provided technical scores based on the documents certified & furnished by the bidders.

The details of technical scores obtained by the bidders are tabulated as hereunder:

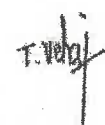

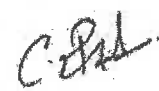
