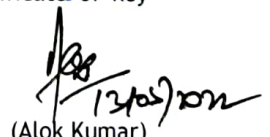

Based on your bid submitted on 07.05.2022 (online) for the work of "Routine Maintenance of 2- lane with paved Shoulders configuration in Jowai- Meghalaya/Assam Section of NH-6 (new) from Km 69.200 to Km 173.200 in the state of Meghalaya (Length = 102.255 Km)" and pursuant to Clause 30 & 32 of ITB, it is hereby notified that your bid for a contract price of Rs. 8,38,45,483/-(Rupees Eight Crores Thirty Eight Lakhs Forty Five Thousand Four Hundred and Eighty Two only) (Inclusive of all taxes) which is 5.99% below of the estimated cost has been accepted for and on behalf of NHAI.
