Minutes of the Bid Evaluation Committee on Financial Proposals

Sub: Construction for New Box Culvert at Km. 232+875, Minor Repair Works Such as Settlement of Approaches near Box Culverts, Patch works and Pot Holes for Kerala Border to Kollegala Section of NH-766 (Old NH-212) from Km. 136.600 to Km. 268.475 in the State of Karnataka under - reg.

The online Tender was invited vide above said notification for the subject work and following details are incorporated in the RFP and Financial proposal:

As per the Bid Evaluation Committee vide Technical Minutes dated 13.05.2022, both the bidders were found to be responsive and accordingly recommended to hoist the final outcome of technical evaluation on e-tenders portal of NHAI and to open the Financial Bids of the 02 Nos. of Technically responsive bidders (**as mentioned in Annexure-II**) on 16.05.2022 at 12:00 Hrs, if possible. Due to issues with DSC signing the opening of Financial bid was delayed and subsequently opened on 25.05.2022. Office order was issued on 24.05.2022 for meeting of Committee for financial evaluation on 26.05.2022.

Accordingly, as per this office vide letter No.455 dated 24.05.2022, the Bid Evaluation Committee has opened the Financial Bids of the 02 Nos. of Technically responsive bidders on 25.05.2022. The details of Financial proposals are as below:

After opening and evaluation of Financial bids **Sri Chidaravalli Doddalinge Gowda Krishna** was L1 Bidder. As per Section-II vide clause 24.1 of RFP, within 20 (twenty) days of the receipt of Letter of Acceptance, the successful Bidder shall deliver to the Employer a Performance Security of **Five percent (05%) (Rs.2,54,757.328)** of the Contract Price, valid for the period of 28 days after the expiry of defect liability period of whole work. The DLP as per RFP is 1 year and validity shall Account for additional 01 months' time to account for BG verification, signing the contract and start date.

As per NHAI Policy Matters-Technical (209-2016) No.NHAI/CM-1/Misc./2016 dt.02.08.2016 and in which vide sl. No. D (i) states that the Regional Officer has been delegated for power of approval for the bids for Maintenance works, where the lowest bid price is upto **05% above** sanctioned cost.

Since, the percentage quoted by the L1 bidder **Sri Chidaravalli Doddalinge Gowda Krishna** is **(+) 4.40%** above of sanctioned cost and which works out to **Rs. 50,95,146.56/-** Including GST at 12% as against the Sanctioned amount of **Rs.48,80,000/-** including GST at 12% and as such it comes within the delegation powers of RO. Accordingly, the same may be approved by RO for issue of LOA to the L1 Bidder.

After issue of LOA, the successful L1 bidder **Sri Chidaravalli Doddalinge Gowda Krishna** has to submit Performance Security at **03%** of the Contract price i.e., **Rs. 1,52,854 /-** within 10 days after receipt of the LOA.

In view of the above, as per the Policy circular the Bid Evaluation Committee recommends to issue LOA to L1 bidder **Sri Chidaravalli Doddalinge Gowda Krishna** for the quoted amount of **Rs. 50,95,146.56/-** including GST at 12% which is **(+) 4.40%** above of the sanctioned cost and under delegation of Regional officer and may be submitted to RO-Bengaluru for approval. Thereafter, LOA to the lowest bidder will be issued after approval from RO-Bengaluru.
